For all articles not specified in this Short Version, the Standard Regulations for Events of the FIA European Championship for Autocross Drivers are valid. The Standard Regulations are distributed to each competitor in the FIA European Championship by his ASN. They are also posted on the Official Notice Board of each event. ## IV. CHECKING

## 9. ADMINISTRATIVE CHECKING

**9.1** Only drivers must report to administrative checking which will be held at Drivers 's paddock – Secretary office on 31<sup>st</sup> July 2009(Friday) from 15h00 to 19h00 and on 1<sup>st</sup> August 2009 (Saturday) from 07h00 to 08h00, but only by waiver of the Clerk of the Course.

#### 10. SCRUTINEERING

10.1 No cars will be allowed to start unless i complies with the current FIA safety regulations (Appendix J and M). The technical delegate appointed by the FIA will be responsible for scrutineering and will have full authority over the national scrutineers.

Any car taking part in the event must be presented by the driver or his official representative to scrutineering which will be held at Driver's paddock – Laminate Hall on 31<sup>st</sup> of July 2009 from 15h30 to 19h30, and 1<sup>st</sup> of August 2009 from 7h00 to 8h00, but only by waiver of the Clerk of the Course. Any car arriving after the closure of scrutineering may be refused permission to start. Any competitor who is unable to attend the formal Scrutineering Session, and who notifies the Clerk of the Course before the beginning ot the Official timed practice, will be scrutineered at a time notified to him and will be subject to a financial penalty. See article 17.

#### 10.2 Noise

For all cars, a limit of 100 dB is imposed, measured with a noise pressure meter regulated at "A" and "SLOW", placed at an angle of 45 degrees to and a distance of 50 cm from the exhaust outlet, with the car's engine turning at 4500 revolutions per minute. (A carpet of 1.50 m x 1.50 m minimum must be placed over the relevant area).

## V. RUNNING OF THE EVENT

## 12. PRACTICE and DRIVERS INFORMATION

12.1 Free practice and two official timed practice, one organised in order and the second in reversed order are obligatory in each division. There will be not more than max. 6 cars in each timed practice session, which will last for 5 laps from the entry of the first car onto the track, but only the time starting from the second lap will count.

The best time of one lap from all official timed practice sessions will determine the starting position for the first Heat. In the event of a tie, the next best lap time of the drivers who have tied will determine the starting position.

Each driver must complete at least one lap in practice. Should this not be the case, in the first qualifying Heat he may be allowed to start at the discretion of the stewards.

Cars from different Divisions will run separately.

The official timed practice will run on Saturday 1<sup>st</sup> August 2009 from 11h00 to 15h00 in order support race D3JB, D1, D3A, D3.

12.2 Information in English and in Slovak language will be given to the drivers in writing during the administrative checking.

## 14. QUALIFYING

There will be 5 laps in the qualifying Heats.

14.4. The positions of cars absent from the grid will remain empty.

In each Heat, the drivers will be classified according to the number of laps completed. For those drivers having completed the same number of laps, the time of crossing the finish line will be decisive. Among the drivers with the same number of points in the Heat, the time will be the deciding factor. The driver coming 1<sup>st</sup> will be awarded 1 point, the 2<sup>nd</sup> 2 points, the 3<sup>rd</sup> 3 points, and so on.

Those drivers who did complete less than 2 laps will be credited with 80 points.

Those drivers who did not start the Heat will be credited with 90 points.

Those drivers who were excluded from the Heat will be credited with 95 points.

Only those drivers having totalised less than 21 points in two Heats will be admitted to the Finals.

## 15. FINALS

There will be 7 laps in the Finals.

Moreover, the Stewards of the meeting themselves or upon the proposal of the Clerk of the Course may decide on any point which is not provided for in the Regulations and apply penalties in conformity with the criteria of the Code, of the European Championships Regulations and of these Supplementary Regulations.

## VI. PARC FERME - RESULTS - PROTESTS

## 18. PARC FERME

Only those cars having taken part in the Finals mus be brought by the drivers to the Parc Fermé immediately after the las race for which the driver qualified. The cars shall remain in the Parc Fermé for at least 30 minutes after the publication of the provisional results and until released by decision of the Stewards. In this area, it is forbidden to make any repair to the vehicle or to carry out refuelling.

## 19. RESULTS

All results will be posted on the notice board in (see 1.4.) and in the Secretariat The results will be posted 10 minutes after each Heat and Finals.

## 20. PROTESTS - APPEALS

**20.1** All protests will be lodged in accordance with the Code.

All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards of the meeting, together with the sum of 500,- €. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit according to following table:

Unofficial Prize Giving will take place in front of the Laminate Hall on Sunday 2<sup>nd</sup> of August 2009 at 17h30. The winners of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> prizes must be present. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race. Official Prize Giving (1<sup>st</sup> - 10<sup>th</sup> place) will take place at the Secretary Office in Paddock at 18h30. The prizes will be awarded in Euros.

#### 22. FIRE EXTINGUISHERS

Each driver is responsible for ensuring that a fire extinguisher of min. 5 kg is available within his own team's area inside the paddock.

#### 23. PROTECTION OF THE ENVIRONMENT

Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.

#### 24. DRIVERS'LIAISON OFFICER

The Drivers' Liaison Officer Mr. Milan Troška will be reached in driver's paddock close to entrance to the track during all the championship. The Drivers' Liaison Officer will be recognisable by yellow vest and his photograph will be hanging on the official notice board and information board.
